



Living In a "perfect storm" of interacting crises: Economic, Political, Social, Environmental, Epidemiological and Global Conscience, we must bring our individual and collective capacities to bear and respond.

Called together in Heidelberg for the twentieth anniversary of the Triple Helix Conference Series, we must renew and apply the triple helix model, developed in response to the innovation gap opened up by the economic and political crises originating in the early twentieth century, to address the crises of our times with our full intellectual capacity and zest.

This year's International Triple Helix Conference organised by the Triple Helix Association in cooperation with the International Triple Helix Institute and supported by DKFZ – Helmholtz Association, is building a broad platform of academics and practitioners to address the local and the global challenges of our time. The conference organisers invite participants with a broad background and interests to join the debates and share findings from empirical research, experiences from policy interventions, and insights from knowledge transfer practice. Plenary discussions will focus on how Triple Helix solutions emerge in crisis situations.

The call for papers includes **16 great** tracks that will enhance discussions and bring together key actors from the field – academics, policy makers, business leaders, NGOs and other boundary spanning facilitators, stirring innovation across the public and private domains.

Arjun Appadurai – keynote speaker on the panel Challenges in the Era of Crises, where he will put an emphasis on "global conscience". Arjun Appadurai is the Paulette Goddard Professor Media, Culture and Communication at New York University. He is an expert on globalization, media and urbanization. His most recent book is 'Banking on Words: The Failure of Language in the Age of Financialization' (University of Chicago, 2015). He has a Ph.D. from The University of Chicago and has held Professorial Chairs taught at the University of Pennsylvania, Yale University and The New School. He is the author of

numerous books and articles and is a Visiting Professor at the Institute for European Ethnology at Humboldt University in 2016-2017. He is a member of the American Academy of Arts and Sciences.
